

The trading of Units on NSE and/or any other Stock Exchange(s) on which the Units are listed will automatically get suspended from the date as may be specified in the said notice and also no off-market transactions shall be permitted by the Depositories.

The portfolio statement will also be displayed on the website of the AMC and AMFI.			
	The Mutual Fund and AMC shall before the expiry of one month from the close of each half year i.e. 31 st March and on 30 th September, host a soft copy of its unaudited financial results on its website (www.unionmf.com) and			

publish an advertisement disclosing the hosting of such financial results on its website, in atleast one English daily newspaper having nationwide circulation and in a newspaper having wide circulation published in the language of the region where the Head Office of the Mutual Fund is situated. The Investors will be able to view and download the Scheme unaudited financial results from the AMC's website. The unaudited financial results will also be displayed on the website of AMFI.

The AMC will also disclose the portfolios of all the schemes of Union Mutual Fund as on the last day of the month on the AMC's website (www.unionmf.com) on or before the tenth day of the succeeding month. The Investors will be able to view and download these monthly portfolio disclosures from the AMC's website.

Further, the AMC will make available the Annual Report of the Scheme within four months of the end of the financial year. The Annual Report shall also be displayed on the website of the AMC and AMFI.

Option to hold Units in dematerialised form

The Unit holders are given an Option to hold the units in Physical form (by way of an Account Statement) or Dematerialized ('Demat') form. The Applicants intending to hold the Units in dematerialised mode will be required to have a beneficiary account with a DP of the NSDL/CDSL and will be required to mention the DP's Name, DP ID No. and Beneficiary Account No. with the DP in the application form at the time of subscription of the Units of the Scheme/Plan/Option.

Further, investors also have an option to convert their physical holdings into the dematerialised mode at a later date. Each Option under each plan held in the dematerialised form shall be identified on the basis of an International Securities Identification Number (ISIN) allotted by National Securities Depositories Limited (NSDL) and Central Depository Services Limited (CDSL). The ISIN No. details of the respective option under the respective plan can be obtained from your Depository Participant (DP) or you can access the website link www.nsdl.co.in or www.cdslindia.com. The holding of units in the dematerialised mode would be subject to the guidelines/procedural requirements as laid by the Depositories viz. NSDL/CDSL from time to time. For further details refer section III 'Units and Offer' in this document.

Transfer of Units

Units held in Physical Form (by way of Account statement) cannot be transferred. The Units of the Scheme held in the dematerialised form will be fully and freely transferable (subject to lock-in period, if any and subject to lien, if any marked on the units) in accordance with the provisions of SEBI (Depositories and Participants) Regulations, 1996 as may be amended from time to time and as stated in SEBI Circular No. CIR/IMD/DF/10/2010 dated August 18, 2010. Further, for the procedure of release of lien if any, the investors shall contact their respective DP.

Application Supported by Blocked Amount (ASBA)

Investors also have an option to subscribe to units of the scheme during the New Fund Offer Period under the Applications Supported by Blocked Amount (ASBA) facility, which would entail blocking of funds in the investor's Bank account, rather than transfer of funds, on the basis of an authorisation given to this effect at the time of submitting the ASBA application form. I. INTRODUCTION

A. RISK FACTORS

i. STANDARD RISK FACTORS:

- Investment in Mutual Fund Units involves investment risks such as trading volumes, settlement risk, liquidity risk, default risk including the possible loss of principal.
- As the price / value / interest rate of the securities in which the Scheme invests fluctuates, the
 value of your investment in the Scheme may go up or down, depending on the various factors
 and forces affecting the capital markets.
- Past performance of the Sponsor/AMC/Mutual Fund does not guarantee future performance of the Scheme.
- Union Capital Protection Oriented Fund Series 7 is only the name of the Scheme and
 does not in any manner indicate either the quality of the Scheme or its future prospects and
 returns.
- The Sponsor is not responsible or liable for any loss resulting from the operation of the Scheme beyond the initial contribution of an amount of ₹1,00,000 (Rupees One Lakh) made by it towards setting up the Mutual Fund.
- Union Capital Protection Oriented Fund Series 7 is not a guaranteed or assured return Scheme
- Although it is intended to seek capital protection on maturity by investing in fixed income securities maturing on or before the tenure of the scheme and seeking capital appreciation by investing in equity and equity related instruments, investors may note that AMC/Fund Manager's investment decisions may not be always profitable. ii. SCHEME SPECIFIC RISK FACTORS:

1. RISKS ASSOCIATED WITH INVESTING IN FIXED INCOME SECURITIES/BONDS:

The following are the risks associated with investment in Fixed Income Securities/Bonds:

Interest Rate Risk: This risk is associated with movements in interest rate, which depend on various factors such as government borrowing, inflation, economic performance etc. Fixed income securities such as government bonds, corporate bonds, and money market instruments etc. run price-risk or interest-rate risk. Generally, when interest rates rise, prices of fixed income securities fall and when interest rates drop, the prices generally increase. The extent of fall or rise in the prices depends upon factors such as coupon, maturity of the security, the yield level at which the security is being traded. The longer the time to a bond's maturity, the greater is its interest rate risk. The NAV of the Scheme is expected to increase from a fall in interest rates while it would be adversely affected by an increase in the level of interest rates.

Re-investment Risk: Investments in fixed income securities may carry re-investment risk as interest rates prevailing on the interest or maturity due dates may differ from the original coupon of the bond. Consequently, the proceeds may get invested at a lower rate.

Spread Risk: Yield Spreads between fixed income securities might change. Eg: Corporate Bonds are exposed to the risk of widening of the spread between corporate bonds and gilts. Prices of corporate bonds tend to fall if this spread widens which will affect the NAV of the Scheme accordingly. Similarly, in case of floating rate securities, where the coupon is expressed in terms of a spread or mark up over the benchmark rate, widening of the spread results in a fall in the value of such securities.

Liquidity Risk: This risk pertains to how saleable a security is in the market or the ease at which a security can be sold at or close to its true value. Trading volumes, settlement periods and transfer procedures may restrict the liquidity of some of the investments. The primary measure of liquidity risk is the spread between the bid price and the offer price quoted by a dealer. The liquidity of debt securities may change, depending on market conditions. At the time of selling the security, the security can become less liquid (wider spread) or illiquid, leading to loss in value of the portfolio. Securities that are unlisted generally carry a higher liquidity risk compared to listed securities.

Money market securities, while fairly liquid, lack a well developed secondary market, which may restrict the selling ability of the Scheme and may lead to the Scheme incurring mark to market losses and losses when the security is finally sold.

Liquidity risk is greater for thinly traded securities, lower rated bonds, bonds that were part of a smaller issue, bonds that have recently had their credit rating downgraded or bonds sold by an infrequent issuer. Bonds are generally the most liquid during the period right after issuance when the bond typically has the highest trading volume.

Credit Risk/ Default Risk: Credit risk is the risk that the issuer of a debenture/ bond or a money market instrument may default on interest and /or principal payment obligations and/or on violation of covenant(s) and/or delay in scheduled payment(s). Even when there is no default, the price of a security may change with expected changes in the credit rating of the issuer.

Government Security is a sovereign security and the default risk is considered to be the least. Corporate bonds carry a higher credit risk than Government Securities and among corporate bonds there are different levels of safety. Credit risks of most issuers of debt securities are rated by independent and professionally run rating agencies. Ratings of Credit issued by these agencies typically range from "AAA" (read as "Triple A" denoting "Highest Safety") to "D" (denoting "Default"). A bond rated higher by a particular rating agency is safer than a bond rated lower by the same rating agency.

Inflation risk: Inflation causes tomorrow's currency to be worth less than today's; in other words, it reduces the purchasing power of a bond investor's future interest payments and principal, collectively known as "cash flows." Inflation also leads to higher interest rates, which in turn leads to lower bond prices. Inflation-indexed securities such as Treasury Inflation Protection Securities (TIPS) are structured to remove inflation risk.

Prepayment Risk: The borrower may repay the receivables earlier than scheduled, which may result in change in the yield and tenor for the Scheme.

Call risk: Some corporate, municipal and agency bonds have a "call provision" entitling their issuers to redeem them at a specified price on a date prior to maturity. Declining interest rates may accelerate the redemption of a callable bond, causing an investor's principal to be returned sooner than expected. In that scenario, investors have to reinvest the principal at the lower interest rates. (Also refer to Reinvestment risk.)

2. <u>RISKS ASSOCIATED WITH INVESTMENTS IN EQUITIES AND EQUITY RELATED SECURITIES:</u>

The scheme proposes to invest in equity and equity related instruments. Equity instruments by nature are volatile and prone to price fluctuations on a daily basis due to both micro and macro factors.

The following are the main risks related to investing in equities:

Market risk: Any type of risk due to the market conditions and evolution, such as volatility in the capital markets, interest rates, changes in policies of the Government, taxation laws or any other political and economic development, which all may negatively affect the prices of the securities invested in by the scheme.

Business risk: Risk related to uncertainty of income caused by the nature of a company's business and having an impact on price fluctuations.

Liquidity risk: This risk pertains to how saleable a security is in the market or the ease at which a security can be sold at or close to its quoted or published price/value.

Securities that are listed on the stock exchange generally carry lower liquidity risk; the ability to sell these investments is limited by the overall trading volume on the stock exchanges.

3. <u>COMMON RISKS ASSOCIATED WITH INVESTING IN FIXED INCOME SECURITIES/BONDS</u> /EQUITIES AND EQUITY RELATED SECURITIES:

Counterparty Risk: This is the risk of failure of counterparty to the transaction to deliver securities against consideration received or to pay consideration against securities delivered, in full or in part or as per the agreed specification. There could be losses to the scheme in case of counterparty default.

Settlement Risk: This is the risk of non-delivery/delay of instruments or payment on settlement day. This non-settlement or delay may lead to opportunity losses. The inability of the Scheme to make purchases in intended securities due to settlement problems could cause the Scheme to miss certain investment opportunities. Fixed income securities relatively run higher settlement risk, which can adversely affect the ability of the fund house to swiftly execute trading strategies which can lead to adverse movements in NAV.

Performance Risk: Performance of the Scheme may be impacted with changes in factors which affect the capital market and in particular the debt market.

Selection Risk: The risk that a security chosen will underperform the market for reasons that cannot be anticipated.

Timing risk: The risk that an investor takes when trying to buy or sell a stock based on future price predictions. Timing risk explains the potential for missing out on beneficial movements in price due to an error in timing. This could cause harm to the value of an investor's portfolio because of purchasing too high or selling too low.

Concentration risk: This is the risk arising from over exposure to few securities/issuers/sectors.

Legislative and fiscal risk: The risk that a change in the tax code or law could affect the value of taxable or tax-exempt income.

4. RISKS ASSOCIATED WITH INVESTING IN DERIVATIVES:

Derivatives are financial contracts designed to create pure price exposure to an underlying commodity, asset, rate, index or event. In general they do not involve the exchange or transfer of principal or title, so investors do not actually buy anything. Rather their purpose is to capture, in the form of value changes, some underlying price change or event.

Derivative products are leveraged instruments and can provide disproportionate gains as well as disproportionate losses to the investor. Execution of such strategies depends upon the ability of the fund manager to identify such opportunities. Identification and execution of the strategies to be pursued by the fund manager involve uncertainty and decision of fund manager may not always be profitable. No assurance can be given that the fund manager will be able to identify or execute such strategies.

The risks associated with the use of derivatives are different from or possibly greater than, the risks associated with investing directly in securities and other traditional investments.

The Scheme may use permitted Index and equity derivative instruments like futures and options or other Index and equity derivative instruments as maybe permitted from time to time.

Derivatives require the maintenance of adequate controls to monitor the transactions entered into, the ability to assess the risk that a derivative adds to the portfolio and the ability to manage the risks.

The risks associated with investments in equity derivatives are as follows:

Market Risk: Derivatives are traded in the market and are exposed to losses due to change in the prices of the underlying and/or other assets and, change in market conditions and factors. The volatility in prices of the underlying may impact derivative instruments differently than its underlying.

Credit Risk: The credit risk is the risk that the counter party will default in its obligations and is generally small as in a derivative transaction there is generally no exchange of the principal amount.

Basis Risk: This risk arises when the derivative instrument used to hedge the underlying asset does not match the movement of the underlying being hedged for example, when a stock is hedged using a derivative, the change in price of the stock and the change in price of the derivative may not be fully correlated leading to basis risk in the portfolio.

Liquidity risk: Asset Price Liquidity:

This risk arises from the inability to sell derivatives at prices that reflect the underlying assets/ rates/ indices, lack of availability of derivatives products across different maturities and with various risk appetite.

Liquidity to meet margin requirements:

Positions in futures may be subjected to increase in margin requirements due to increase in volatility and/or change in market conditions. Such increase in margin/collateral requirements might result in forced selling of assets and/or maintaining of cash at higher level than normally desired.

Valuation Risk: The risk of mispricing or improper valuation of derivatives due to inadequate trading data with good volumes.

Systemic Risk: The risk arising due to failure of operational processes followed by the exchanges and OTC participants for the derivatives trading.

Operational Risk: This is the risk arising due to failure of operational processes followed by the exchanges for the derivatives trading.

Exposure Risk: An exposure to derivatives in excess of the hedging requirements can lead to losses. An exposure to derivatives can also limit the profits from a plain investment transaction.

Risk of investing in long dated options:

One of the possible strategies for the scheme is investing the entire allocation of equity and equity related portion of the asset allocation into long dated index options with maturity of the options as near to the scheme's maturity as possible. Since long dated Nifty Index options with maturity of more than one year are presently available only at semi- annual intervals, there is a possibility of the options expiring prior to the maturity of the scheme. In such a case, the returns of the equity portion of the scheme on maturity may not coincide with the returns of the equity market on maturity. Further, if the options expire out of money and the equity market rallies after the expiry of the option, the scheme may face a loss to the extent of the premium paid for options and not provide positive returns in line with the market.

Risk of investing in multiple short dated options:

One of the possible strategies for the scheme is investing part or the entire allocation of equity and equity related portion of the asset allocation into multiple short dated options across the tenure of the scheme. Since, short dated options would be purchased at different times and at costs prevailing at the time of such purchase, the returns generated by such a strategy could be significantly different from the returns generated from a buy and hold strategy upto the maturity of the scheme. Further, if the options expire out of money in the first period of such investments and the equity market rallies after the expiry of the option, the scheme may face a loss to the extent of the premium paid for options and not provide positive returns in line with the market.

5. <u>RISKS ASSOCIATED WITH CLOSE ENDED NATURE OF THE SCHEME AND LISTING OF UNITS ON STOCK EXCHANGE(S):</u>

As mentioned above, the unit holders may note that owing to the close ended nature of the Scheme no redemption / repurchase of units shall be allowed prior to the maturity of the scheme with the AMC/Mutual Fund. However, investors who wish to exit from the scheme before maturity, may do so through the Stock Exchange route. The risks associated with the use of the Stock Exchange platform is stated below:

- Trading in the Units of the Scheme on the Stock Exchange may be halted because of the market conditions or for reasons in view of the Exchange Authorities or SEBI rendering trading in the Units of the Schemes inadvisable. In addition, trading of the Units of the Schemes is subject to trading halts caused by extraordinary market volatility and pursuant to the Stock Exchange's/market regulator's 'circuit filter' rules. There can be no assurance that the requirements of the concerned Stock Exchange necessary to maintain the listing of the units of the Schemes will remain unchanged.
- Unit holders may find it difficult or uneconomical to liquidate their investments at any particular time.
- Although the Units of the Scheme are proposed to be listed on the Stock Exchange, there can be no assurance that an active secondary market will be developed or be maintained.
- The Units of the Scheme may trade at a significant discount or premium to the NAV on the Stock Exchange. The price at which the Schemes are traded on the exchange will fluctuate in accordance with market supply and demand for the units of the Schemes as well as be affected by changes in NAV.
- Any changes in trading regulations by the Stock Exchange or SEBI among other things may also result in a wider premium/ discount to the NAV of the Scheme.
- The Trustee reserves the right to list the Units of the Scheme on any other recognized Stock Exchange in India, as may be deemed fit, in which case the investors may face risks related to an undeveloped market, delay in settlements etc.
- For Units held in Demat form, the records of the depository are final with respect to the number of units available to the credit of unit holder. Settlement of trades, repurchase of units by the Mutual Fund on the maturity date will depend upon the confirmations to be received from depository(ies) on which the Mutual Fund has no control.

6. OTHER SCHEME SPECIFIC RISKS RELATING TO CAPITAL PROTECTION & RATING:

- The scheme offered is "oriented towards protection of capital" and "not with guaranteed returns". Further, the orientation towards protection of the capital originates from the portfolio structure of the scheme and not from any bank guarantee, insurance cover etc.
- The ability of the portfolio to meet capital protection on maturity to the investors may be impacted by changes in government policies, interest rate movements in the market, credit defaults by bonds and expenses.
- The rating provided by CARE, only assesses the highest degree of safety regarding timely receipt of payments from the investments that the Scheme has made and does not denote any opinion on the stability of the NAV of the Scheme. The rating should, however, not be construed as an indication of expected returns, prospective performance of the mutual fund scheme, NAV or of volatility in its returns. A capital protection oriented scheme rating is the rating of a structured obligation and is conditional on the fulfilment and maintenance of certain minimum criteria by the asset management company (AMC). CARE's methodology for assessing the strength of the portfolio structure, in terms of how well it provides capital protection, involves a comprehensive analysis of the investment strategy adopted by the AMC, the prevailing market conditions (with respect to the various instruments that the scheme invests in) and the AMC's track record & past performance. Given these parameters, CARE assesses the structure of the portfolio under various market scenarios and stressed

- conditions. CARE then estimates the likelihood of a shortfall in the net asset value, with respect to the face value of the units of the scheme on maturity. Higher rating is assigned which have a lower likelihood of shortfall of NAV.
- The rating would be reviewed on a quarterly basis or at such other periodic intervals as may
 be required by CARE and CARE reserves the right to suspend, withdraw or revise the ratings
 granted to the Scheme at any time, on the basis of any new information or unavailability of
 information or any other circumstances, which CARE believes may have an impact on the
 above ratings.

B. REQUIREMENT OF MINIMUM INVESTORS IN THE SCHEME

The Scheme shall have a minimum of 20 investors and no single investor shall account for more than 25% of the corpus of the scheme. These conditions will be complied with immediately after the close of the NFO itself i.e. at the time of allotment. In case of non-fulfilment with the condition of minimum 20 investors, the scheme shall be wound up in accordance with Regulation 39 (2) (c) of SEBI (MF) Regulations automatically without any reference from SEBI. In case of non-fulfilment with the condition of 25% holding by a single investor on the date of allotment, the application to the extent of exposure in excess of the stipulated 25% limit would be liable to be rejected and the allotment would be effective only to the extent of 25% of the corpus collected. Consequently, such exposure over 25% limits will lead to refund within 5 Business Days of the date of closure of the New Fund Offer.

The information given is included only for general purpose and is based on advice received by the AMC regarding the law and practice currently in force in India as on the date of this SID and the investors should be aware that the relevant fiscal rules or their interpretation may change. II. INFORMATION ABOUT THE SCHEME

A. NAME, TYPE & MATURITY OF THE SCHEME

"Union Capital Protection Oriented Fund - Series 7" is a Close-ended Capital Protection Oriented Scheme.

The Scheme will have a maturity of 1100 days from the date of allotment including the date of allotment.

If the maturity date falls on a non-business day, then the maturity date shall be the next Business Day.

B. WHAT IS THE INVESTMENT OBJECTIVE OF THE SCHEME?

The investment objective of the Scheme is to seek capital protection on maturity by investing in fixed income securities maturing on or before the tenure of the scheme and seeking capital appreciation by investing in equity and equity related instruments.

However, there is no assurance that the investment objective of the Scheme will be realized and the Scheme does not assure or guarantee any returns. The Scheme is "oriented towards protection of capital" and not "with guaranteed returns". Further, the orientation towards protection of the capital originates from the portfolio structure of the scheme and not from any bank guarantee, insurance cover etc.

C. HOW WILL THE SCHEME ALLOCATE ITS ASSETS?

Under normal circumstances, the asset allocation pattern will be as follows:

The Scheme does not intend to invest in Securitized Debt (including Pass Through Certificates), Debt Derivatives, Repo/Reverse Repo in corporate debt securities, overseas/ foreign securities.

Further, the Scheme does not intend to engage in stock/securities lending and short selling or participate in credit default swap transactions.

The Scheme shall make investments in debt securities maturing on or before the maturity of the Scheme. In accordance with SEBI (MF) Regulations and circulars thereto, the debt component of the portfolio will have the highest investment grade rating (presently, AAA and A1+).

Investment in Equity Derivative instruments will not exceed 20% of the net assets of the Scheme. The scheme will only invest in exchange traded options and futures. The Scheme may use equity derivatives for such purposes as may be permitted by the Regulations, including for the purpose of hedging and portfolio balancing, based on the opportunities available and subject to guidelines issued by SEBI from time to time.

In accordance with SEBI Circular No. Cir/ IMD/ DF/ 11/ 2010 dated August 18, 2010, the cumulative gross exposure to equity, debt and derivative positions will not exceed 100% of the net assets of the Scheme. For further details, please refer to Point viz. "Limitations and Restrictions for investments in

Derivatives" under the heading "What are the investment restrictions?" under Section II in this document.

Pending deployment of funds of the Scheme in securities and in terms of the investment objective, the AMC may park the funds of the Scheme in short term deposits of Scheduled Commercial Banks, subject to the Guidelines issued by SEBI vide its circular dated April 16, 2007, as amended from time to time.

The proposed portfolio structure has been evaluated by CARE; a SEBI registered Credit Rating Agency from the view point of assessing the highest degree of safety regarding timely receipt of payments from the investments that the Scheme has made. Further, the rating would be reviewed on a quarterly basis or at such other periodic intervals as may be required by CARE. The asset allocation mix (Debt: Equity) would be in line with the rating letter issued by the rating agency depending upon the prevailing interest rates. Further, such asset allocation mix (Debt: Equity) shall be followed only at the time of initial investment.

Illustration [The below example is for illustration purposes only and purely to explain the concept of the asset allocation mix of the Scheme. The actual initial asset allocation mix (Debt: Equity) can be different and shall be within the provisions of the overall Asset Allocation and Investment Pattern mentioned in the SID and as per the asset mix provided by CARE]:

Suppose, the initial indicative asset allocation mix (Debt: Equity) provided by CARE is as follows:

In the above scenario, the Scheme would initially deploy at least 86% of the funds collected during the NFO period in debt securities / money market instruments with an intention to protect the capital at the time of maturity of the Scheme. Subsequently, the asset allocation will be decided in consultation with the rating agency such that the debt portion will aim, at all times, to preserve the capital. For example, suppose the initial investment was as follows:

At the end of the first year, the value of the investment is:

In this case, the fund manager need not re-balance the equity investment provided the debt portion is sufficient to preserve the capital.

The Fund Manager may alter the asset allocation during subsequent deployment of funds provided such deployment is generated out of appreciation in value of existing investments. While altering such asset allocation, the Fund Manager would endeavour that the capital remains protected on maturity and that the rating of the Scheme is not adversely impacted.

The asset allocation shall be in line with the asset allocation suggested by CARE. Further, in case either of the above "Debt: Equity" mix is revised by CARE; the Fund Manager will deploy the funds in accordance with the asset mix indicated by CARE.

The Fund will diversify its debt portfolio across instruments by investing in securities rated by various Rating Agencies. The following criteria will be used for selecting the portfolio securities:

- The Scheme is rated by CARE. However, the scheme shall not invest more than 20% (in value) of the net assets of the Scheme at the time of investment in securities rated by CARE, as CARE has rated the Fund. In computing the ceiling of 20%, the securities issued by Public Sector Undertakings, Nationalized Banks and Government Companies will be excluded;
- Further, the scheme shall invest only in such securities which mature on or before the date of
 the maturity of the scheme. In case of securities with put options, the maturity shall be
 reckoned with respect to the final maturity date and not the "put option" date. Further, debt
 component of the portfolio will have highest investment grade rating;
- The Fund Manager shall not invest in Securities which have a yield of more than 100 bps over the yield of AAA securities/or equivalent ratings as per CRISIL/ICRA/ FIMMDA bond matrix. The Fund Manager does not have any discretion over the yield provided by these Agencies since these Agencies are independent of the funds. The Fund Manager shall not have any right to change the yields as provided by these agencies. The restriction shall be applicable at the time of investment and not thereafter. Thus, if the Fund Manager has invested in a security based upon the above parameter and then the yield moves beyond 100 bps, the Fund Manager shall not be liable to liquidate those securities;
- The total exposure of the Scheme in a particular sector (excluding investments in Bank CDs, CBLO, G-Secs, T-Bills, short term deposits of scheduled commercial banks and AAA rated securities issued by Public Financial Institutions and Public Sector Banks) shall not exceed 25% of the net assets of the Scheme. For the purposes of the sector exposure limit, AMFI sector classification of issuers would be considered.

Provided that the Scheme may have an additional exposure to financial services sector (over and above the limit of 25%) not exceeding 10% of the net assets of the Scheme by way of increase in exposure to Housing Finance Companies (HFCs). Provided further that the additional exposure to such securities issued by HFCs are rated AA and above and these HFCs are registered with National Housing Bank (NHB) and the total investment/ exposure in HFCs shall not exceed 25% of the net assets of the Scheme.

The structure of the portfolio of this scheme will be continuously monitored by the Trustee and will be reported by the Trustee in the half-yearly Trustee Report. Further, the AMC will also report on this aspect in its bimonthly Compliance Test Report.

Change in Investment Pattern

The Scheme may review the above pattern of investments based on views on interest rates and asset liability management needs. However, at all times the portfolio will adhere to the overall investment objectives of the Scheme. Subject to the Regulations, the asset allocation pattern indicated above may change from time to time, keeping in view market conditions, market opportunities, applicable regulations, legislative amendments and political and economic factors. These proportions can vary substantially depending upon the perception of the fund manager; the intention being at all times to seek to protect the interests of the Unit holders. Such changes in the investment pattern will be for short term and for defensive considerations only. In case of deviation, the portfolio would be rebalanced within 30 days from the date of deviation, subject to the disclosures made under the asset allocation pattern as stated above. In case the same is not aligned to the above asset allocation pattern within 30 days, justification shall be provided to the Investment Committee of the AMC and reasons for the same shall be recorded in writing. The Investment committee shall then decide on the course of action.

COMPARISON WITH EXISTING OPEN ENDED SCHEMES:

The existing open-ended products of Union Mutual Fund are either open ended Debt, Liquid, Hybrid or Equity funds, hence, the 'Close Ended Capital Protection Oriented Scheme' under consideration cannot be compared with any of the existing open ended Schemes of the Fund.

D. WHERE WILL THE SCHEME INVEST?

The corpus of the Scheme will be invested in Debt instruments & money market instruments, Equity and Equity related instruments, schemes of mutual funds, and short term deposits which will include but are not limited to the following:

INVESTMENT IN DEBT INSTRUMENTS:

A brief description on the different types of debt instruments is stated below:

- Securities created and issued by the Central and State Governments:

 Securities created and issued by the Central and State Governments as may be permitted by RBI, securities guaranteed by the Central and State Governments (including but not limited to coupon bearing bonds, zero coupon bonds and treasury bills). State Government Securities (popularly known as State Development Loans or SDLs) are issued by the respective State
- Debt instruments issued by Domestic Government Agencies and statutory bodies, which may or may not carry a Central / State Government guarantee.
- Corporate Bonds of public sector or private sector undertakings.

Government in co-ordination with the RBI.

- Corporate debt and securities (of both public and private sector undertakings) including Bonds, Debentures, Notes, Strips, etc.
- Debt instruments (both public and private sector) issued by Banks / Development Financial Institutions.
- Money Market Instruments permitted by SEBI including alternative investments for the call money market as may be provided by RBI to meet the liquidity requirements. A brief description of Money Market Instruments are provided below:
 - <u>Certificate of Deposits (CDs)</u>: Certificate of Deposit (CD) is a negotiable money market instrument issued by Scheduled Commercial Banks (SCBs) and select All India Financial Institutions (FIs) that have been permitted by the RBI to raise short term resources. The maturity period of CDs issued by the SCBs is between 7 days to 1 year, whereas, in case of FIs, maturity is 1 year to 3 years from the date of issue. CDs also are issued at a discount to face value and can be traded in secondary market.
 - Collateralized Borrowing & Lending Obligations (CBLO): Collateralized Borrowing and Lending Obligations (CBLO) is a money market instrument that enables entities to borrow and lend against sovereign collateral security. The maturity ranges from 1 day to 90 days and can also be made available up to 1 year. Central Government securities including Treasury Bills are eligible securities that can be used as collateral for borrowing through CBLO
 - Commercial Papers (CPs): Commercial Paper (CP) is an unsecured negotiable money market instrument issued in the form of a promissory note, generally issued by the corporates, primary dealers and All India Financial Institutions as an alternative source of short term borrowings. CP is traded in secondary market and can be freely bought and sold before maturity. CP can be issued for maturities between a minimum of 15 days and a maximum up to 1 year from the date of issue.
 - Repo/Reverse Repo: Repo (Repurchase Agreement) or Reverse Repo is a transaction in which two parties agree to sell and purchase the same security with an agreement to purchase or sell the same security at a mutually decided future date and price. The transaction results in collateralized borrowing or lending of funds. Presently in India, Central Government Securities, State Government securities, T-Bills and permitted corporate debt securities are eligible for Repo/Reverse Repo. However, the Scheme, does not intend to participate in Repo/Reverse Repo transactions in corporate debt securities.
 - Treasury Bill (T-Bill): Treasury Bills (T-Bills) are issued by the Government of India or State Governments to meet their short term borrowing requirements. T-Bills are issued for maturities of 91 days, 182 days and 364 days. T-Bills are issued at a discount and for a fixed period.
- Non-convertible debentures and bonds: Non-convertible debentures as well as bonds are securities issued by companies / institutions promoted / owned by the Central or State Governments and statutory bodies which may or may not carry a Central/State Government guarantee, public and private sector banks, all India Financial Institutions and Private Sector Companies. These instruments may be secured or unsecured against the assets of the Company and generally issued to meet the short term and long term fund requirements. The Scheme may also invest in the non-convertible part of convertible debt securities.

• INVESTMENT IN EQUITY AND EQUITY RELATED INSTRUMENTS:

Equity related securities include, but are not limited to:

- i. Equity Warrants and Convertible Instruments
- ii. Fully Convertible debentures, Debentures, Partly Convertible Debentures, unlisted securities, initial public offerings, private placements etc.
- iii. Equity Derivatives (Only exchange traded options and futures)

Options:

An option is a contract which provides the buyer the option (also called the holder) the right, without the obligation, to buy or sell a specified asset at an agreed price on or upto a particular date. For acquiring this right the buyer has to pay a premium to the seller. The seller of the option (known as writer of the option) on the other hand has the obligation to buy or sell that specified asset at the agreed price. An option contract may be of two kinds, viz., a call option or a put option. An option that provides the buyer the right to buy is a call option whereas an option that provides the buyer the right to sell is a put option. Options are of two types, viz., European and American. In a European option, the holder of the option can only exercise his right on the date of expiration. In an American option, he can exercise this right anytime between the purchase date and the expiration date. Pursuant to SEBI circular - Cir/IMD/ DF/ 11/ 2010 dated August 18, 2010, the Scheme shall not write options or purchase instruments with embedded written options.

Futures:

A futures contract is an agreement between the buyer and the seller for the purchase and sale of a particular asset at a specific price on a specific future date. The price at which the underlying asset would change hands in the future is agreed upon at the time of entering into the contract. The actual purchase or sale of the underlying asset involving payment of cash and delivery of the instrument does not take place until the contracted date of delivery. A futures contract involves an obligation on both the parties to fulfill the terms of the contract. Currently, futures contracts have a maximum expiration cycle of 3-months. A futures contract on the stock market index gives its owner the right and obligation to buy or sell the portfolio of stocks characterized by the index. Stock index futures are cash settled; there is no delivery of the underlying stocks.

iv. Any other securities / instruments as may be permitted by SEBI from time to time.

• INVESTMENTS IN UNITS OF MUTUAL FUND SCHEMES

The Scheme may invest in Debt and Liquid schemes managed by the AMC or in the schemes of any other mutual funds without charging any fees, in conformity with the investment objective of the Scheme and in terms of the prevailing SEBI (MF) Regulations. Provided that aggregate inter-scheme investment made by all schemes under the same management or in the schemes under the management of any other Mutual Fund/Asset Management Company shall not exceed 5% (or such other permitted limit), of the Net Asset Value of the Mutual Fund.

• INVESTMENT IN SHORT TERM DEPOSITS

Pending deployment of funds and as per the investment objective of the Scheme, the funds may be parked in short term deposits of Scheduled Commercial Banks, subject to guidelines and limits specified by SEBI vide its circular dated April 16, 2007, as amended from time to time.

The aforementioned securities may be acquired through initial public offering (IPOs), secondary market, private placement, rights offers, negotiated deals. Further investments in debentures, bonds and other fixed income securities will be in instruments which have been assigned highest investment grade rating by the Credit Rating Agencies.

The Scheme shall not invest in unrated debt instruments. For this purpose, unrated debt securities shall exclude instruments such as CBLO, Reverse Repo, short term deposit and mutual fund units to which rating is not applicable.

The securities / instruments mentioned above and such other securities the Scheme is permitted to invest in could be listed, unlisted, privately placed, secured, unsecured, rated and of any maturity subject to investment limits specified under sub-section I of Section II of this Document.

For applicable regulatory investment limits please refer to the paragraphs under the Section on "What are the Investment Restrictions?" further in this document.

Details of various derivative strategies/examples of use of derivatives have been provided under the section "*Trading in Derivatives*" further in this document.

The Fund Manager reserves the right to invest in such securities as maybe permitted from time to time and which are in line with the investment objectives of the Scheme.

E. WHAT ARE THE INVESTMENT STRATEGIES?

To achieve the investment objective of the Scheme, an appropriate percentage (as specified in this Scheme Information Document) of the corpus will be invested in "AAA" and equivalent rated fixed income securities with maturities in line with the maturity of the Scheme with an aim to protect capital at the time of maturity. The remaining proportion as specified in the Scheme Information Document will be predominantly invested in Equity and Equity related instrument (including Equity Index linked derivatives) for capital appreciation for the investors.

For the Equity portion, the scheme could gain exposure to the Equity markets through exchange traded Call Options. The investment team will evaluate the prevailing premium levels on the Call options with tenure suitable to the scheme. The scheme could in such a case implement a buy and hold (passive investment) strategy for the Equity Index Call Options held, or buy a series of shorter term options. If the premium for the aforementioned Call Options are at a level that would be prohibitive for the scheme to purchase or if such options were not to be available, the scheme may consider gaining exposure to the Equity markets through either futures and/or long Equity positions. Such equity portion could be managed actively.

While selecting equities, the investment team shall scout the market for opportunities and shall evaluate the individual companies on their merits, leading to the bottom-up investment decision. For selection of the fixed income securities, the AMC will be guided by fundamental research and analysis, ratings assigned by domestic Credit Rating Agencies, macroeconomic factors etc. In addition, the investment team of the AMC will carry out an internal in-depth credit evaluation of securities proposed to be invested in. The credit evaluation will essentially be a bottom up approach and include financial statement analysis, a study of the operating environment of the issuer, the past track record as well as the future prospects of the issuer and the short term / long term financial health of the issuer, prospects of the industry etc.

The investment team of the AMC will continuously monitor and review the macroeconomic environment including the political and economic factors, money supply in the system, Government borrowing programme and demand and supply of debt instruments, credit pick up among others, affecting the liquidity and interest rates.

Example:

The below example is for illustration purposes only and purely to explain the concept of the scheme in the event, a buy and hold strategy involving long maturity options is used within the equity and equity related instruments portion of the scheme. This illustration should not be taken as any indication of either capital protection or equity market returns. The actual allocation can be different and shall be within the provisions of the Asset Allocation and Investment Pattern mentioned in the SID. The actual allocation & performance would depend upon prevailing market conditions. Within the specified limit, the actual expense ratio could be higher or lower than the assumption below:

The scheme duration is assumed to be 1100 days; Total investment amount is assumed ₹100 with interest rate assumed @ 8.00% p.a. at the time of investment, option premium assumed 24.4% and total expense assumed ₹7.50 for the period. In order to offer downside protection at the end of the

tenure/duration, the fund will be assumed to invest ₹ 86 in Debt and Money market and securities. The remaining ₹14 can be invested in Option premium. For this eq., it is assumed that the Option premium is 24.4%, with ₹ 14 available for investment in options.

Let's now look at potential investor returns in various market scenarios

- If market goes up by 20% CAGR for 1100 days: The maturity value of the ₹100 invested would be ~ ₹141.99 which implies a CAGR of 12.34%.
- If market goes up by 15% CAGR for 1100 days: The maturity value of the ₹100 invested would be ~ ₹130.03 which implies a CAGR of 9.10%.
- If market goes down or stays flats at the end of 1100 days, the Maturity value would be same as ₹100 which is the same as the amount invested.

Investments in Mutual Fund Units:

To avoid duplication of portfolios and to reduce expenses, the Scheme may also invest in debt and liquid schemes managed by the AMC or in the debt and liquid schemes of other mutual funds without charging any fees, and in line with the investment objectives of the Scheme and provided that aggregate inter-scheme investment made by all schemes managed by the AMC either in its own schemes or of any other Mutual Fund shall not exceed 5% (or such other permitted limit), of the Net Asset Value of the Fund.

Investment Process:

Decision making process:

For debt and money market instruments the investment process shall be broadly classified as:

The Fund Managers shall take a view on the broad direction of the markets including interest rate outlook. The Credit Analyst along with the Fund Managers shall have the responsibility of individual security analysis, while the dealers shall execute the trading mandates with a view to obtaining the best execution in terms of price and quantity.

Further, the Fund Managers, while buying / selling securities for the scheme shall take into account the following main factors:

- ✓ Interest Rate Outlook✓ Compliance with SEBI Guidelines
- ✓ Risk Management Guidelines
- ✓ Yield to Maturity of th✓ Yield curve analysis Yield to Maturity of the instrument
- ✓ Liquidity of the instrument
- ✓ Credit Rating
- ✓ Credit spreads

As the Scheme is a close ended Fund, in accordance with SEBI Circular No. Cir/ IMD/ DF/12 /2011 dated August 01, 2011 the following provisions may be noted:

Credit evaluation policy for investments in debt securities: While the investment team shall look at each investment option in detail, the following broad framework shall help the team in managing the funds. The key aspects of the credit evaluation framework are:

1. Creation and Maintenance of an Investment Universe:

Investment will be made in securities of the companies forming part of the 'Investment Universe' (Credit Universe).

2. In-house credit appraisal:

The credit analyst shall prepare an initiation note to introduce a Company/Issuer into the 'Investment Universe' after a detailed analysis. The Company/Issuer shall be discussed between Credit Analyst, Fund Manager, Head of Fixed Income and Chief Investment Officer and if found appropriate, admitted to the 'Investment Universe'.

3. Tier system of monitoring:

For better credit monitoring, the Companies/Issuers forming a part of the Investment Universe will be segregated into tiers based on the risk perception.

4. Exposure Norms:

Internal Exposure norms will be defined and approved by the Investment Committee.

Individual Credit Analysis: The analyst shall examine the following aspects of the Company/Issuer:

- ✓ Management Quality
- ✓ Financial Analysis
- ✓ Business Analysis
- ✓ Industry Analysis
- ✓ Regulatory Environment
- ✓ Auditors report and qualification

Sector Exclusions: The AMC may define a list of sectors in which investments may not be made, depending on the prevalent market conditions. The Scheme shall not invest in the Real Estate Sector, Retail Sector, Gem & Jewellery Sector.

Intended asset allocation for the Scheme: The following matrix shall guide the investment exposure (as a percentage of debt component) for this Scheme subject to the guidelines prescribed by CARE from time to time:

Note:

- a. The floors and ceilings within a range of 5% of the intended allocation (%) against each sub asset class/credit rating has been provided in the table above.
- b. In case of non-availability of and taking into account the risk reward analysis of CPs, NCDs, the Scheme may invest in CBLOs/CDs having highest credit rating (A1+)/ Treasury Bills/ Reverse Repos.
- c. At the time of building up the portfolio post NFO and towards the maturity of the Scheme, there may be a higher allocation to cash and cash equivalent.
- d. All investment shall be made based on the rating prevalent at the time of investment. However, in case of an instrument having dual ratings, the most conservative publicly available rating would be considered.
- e. In the event of any deviations from the floor and ceiling of credit ratings specified for any instrument, the same shall be rebalanced within 30 days from the date of the said deviation. In case the same is not rebalanced within 30 days, justification shall be provided to the Investment Committee of the AMC and reasons for the same shall be recorded in writing. The Investment committee shall then decide on the course of action.
- f. The Scheme will not make any investments in unrated debt securities. However, the scheme will make investment in derivative instruments. Please refer the headings: 'How will the scheme allocate its assets?', 'Where will the scheme invest?', 'Trading in Derivatives' and 'What are the investment restrictions?' for disclosures.

There will not be any variation between the intended portfolio allocation and the final portfolio allocation except the exceptions mentioned above (points b, c, and e).

Credit Research and Monitoring of Money Market and Debt Instruments:

The investment team will look at each issue in detail; the following broad framework shall help the team in managing the funds. Following are the key aspects of the process:

- ✓ Creation and Maintenance of an Investment Universe
- ✓ In-house credit appraisal
- ✓ Tier system of monitoring
- √ Exposure Norms

For equity and equity related instruments the investment process shall be broadly classified

- 1. Asset Allocation: Based on the macro-economic outlook and the macro-research, the Fund manager shall take a call on the asset allocation in terms of Cash, Equities and Equity derivatives (only exchange traded futures and options) within the permissible limits for the fund.
- Sector Allocation: The sector allocation shall be decided based on the macro factors and the attractiveness of the various sectors.
- 3. Individual Securities Selection: Research forms a very important part of the portfolio creation process and superior performance comes from superior security selection based on research capabilities. The Research Analysts would look at the following factors while analysing the companies in the investible universe:

✓ Quantitative Factors

- ✓ Financial strength
- ✓ Profit Margin
- ✓ Sales growth
 ✓ Return On Capital Employed
- ✓ Valuation

✓ Qualitative Factors

- ✓ Business of the company and brief history✓ Management and promoters
- ✓ Product profile
- ✓ Customer/market for the products
- ✓ Business risk
- ✓ Corporate governance

√ Market Factors

- ✓ Avg. daily volumes, market capitalization, Shareholding pattern/free floats etc.
- Portfolio Creation: In creating the portfolio, the fund manager shall look at various factors like the suitability of the security for the portfolio, which shall include the riskiness of the security, the growth prospects, the volume, free float, market capitalization, the sector to which the security belongs etc. before allocating a desired weight to the security.
- Portfolio Performance Review: The investment and the risk team would review the performance of the portfolio and the portfolio composition and accordingly re-balance the portfolio to bring it in line with the desired characteristics.

TRADING IN DERIVATIVES:

The scheme intends to use derivatives as may be permitted under the Regulations from time to time. The same shall be within the permissible limit prescribed by SEBI (Mutual Fund) Regulations from time to time.

Derivative transactions that can be undertaken by the Scheme include a wide range of instruments, including, but not limited to

- Options
- Futures
- Any other instrument, as may be regulatorily permitted

Derivatives can be either exchange traded or can be Over the Counter (OTC). Exchange traded derivatives are listed and traded on Stock Exchanges whereas OTC derivative transactions are generally structured between two counterparties. However, the Scheme would only invest in Exchange Traded Equity Derivatives.

DERIVATIVES STRATEGY:

Equity Derivatives Strategy:

OPTIONS:

Option contracts are of two types - Call and Put; the former being the right, but not obligation, to purchase a prescribed number of shares at a specified price before or on a specific expiration date and the latter being the right, but not obligation, to sell a prescribed number of shares at a specified price before or on a specific expiration date. The price at which the shares are contracted to be purchased or sold is called the strike price. Options that can be exercised on or before the expiration date are called American Options, while those that can be exercised only on the expiration date are called European Options. Option contracts are designated by the type of option, name of the underlying, expiry month and the strike price. Thus, options can be used to earn less volatile returns, earn the premium or use for hedging purposes etc.

Strategies that use Options and the objectives of such strategies:

(a) <u>Call Option (Buy)</u>: The fund buys a call option at the strike price of say ₹1000 and pays a premium of say ₹50, the fund would earn profits if the market price of the stock at the time of expiry of the option is more than ₹ 1050 being the total of the strike price and the premium thereon. If on the date of expiry of the option the stock price is below ₹ 1000, the fund will not exercise the option while it loses the premium of ₹ 50.

Risk associated with this strategy:

- Lack of opportunities available in the market
- Inability of the derivatives to correlate perfectly with underlying security
- Execution risk, whereby the rates seen on the screen may not be the rates at which the ultimate execution takes place.
- (b) <u>Put Option (Buy)</u>: The fund buys a Put Option at ₹ 1000 with the underlying security trading at ₹ 1000 by paying a premium of say ₹ 50. If the stock price goes down to ₹ 900, the fund would protect its downside and would only have to bear the premium of ₹ 50 instead of a loss of ₹ 100 whereas if the stock price moves up to say ₹ 1100 the fund may let the Option expire and forego the premium thereby capturing ₹ 100 upside in the underlying security held by the Fund.

Risk associated with this strategy:

- · Lack of opportunities available in the market
- Inability of the derivatives to correlate perfectly with underlying security
- Execution risk, whereby the rates seen on the screen may not be the rates at which the ultimate execution takes place.

The above option positions can be initiated in both index based options as well as stock specific options.

INDEX FUTURES

Index Futures have been introduced by BSE and NSE and three futures of 1 month, 2 months, and 3 months are presently traded on these exchanges. These futures expire on the last working Thursday of the respective months. The Index futures are cash settled and there is no delivery of the underlying stock. The Profitability of the Index / Stock Future as compared to underlying individual securities / security will inter-alia depend on:

- Carrying Cost
- Interest available on surplus funds
- Transaction Costs
- Cost Associated with rolling over of the futures trade, if applicable
- Liquidity in the markets etc.

Strategies that employ index futures and their objectives:

The fund has an existing equity portion invested in a basket of stocks. In case the fund manager has a view that the equity markets are headed downwards, the fund can hedge the exposure to equity either fully or partially by initiating sell futures positions in the index. A long position can be initiated by the fund by buying futures positions in the index against the available cash and permissible equivalents. The extent to which this can be done is determined by existing guidelines.

Risk associated with this strategy:

- 1. Lack of opportunities available in the market
- 2. Inability of the derivatives to correlate perfectly with underlying indices
- 3. Execution risk, whereby the rates seen on the screen may not be the rates at which the ultimate execution takes place.

Illustration:

An example of typical future trade and associated cost as compared to purchasing the underlying index stocks is illustrated below:

If the Nifty (Index) was 5850 at the beginning of a month and the quotes for the three futures were as under:

The Fund can make an actual purchase of the stocks in the Index at the Index level of 5850 or buy one month future at the offer price of 5885 as illustrated above. The cost of employing both the strategies is illustrated below:

C. Return on Surplus Funds left after paying margin (assumed 10% return on the remaining 90% of the funds left after paying 10% margin) (10%*5850*90%*30 days/365)	43.27	Nil

Now if on the date of expiry the Index closes at 5900, then the strategy of purchasing one month future would yield a gain of $\stackrel{?}{\sim}46.5$ (5900-5850-3.5) while the purchase of the underlying securities would result in a gain of $\stackrel{?}{\sim}32.45$ (5900-5850-17.55).

STOCK FUTURES:

Individual stock futures are also available in the Indian Equity Markets. Stock futures trade either at a premium or at discount to the spot prices, the level of premium generally reflects the cost of carry. Stock specific issues may have a bearing on futures as speculators may find futures as a cost-effective way of executing their view on the stock. However, such executions usually increase the premium/discount to the spot significantly, thereby giving rise to arbitrage opportunities for a fund.

Strategies that employ stock specific futures and their objectives:

(a) Selling spot and buying future: In case the fund holds the stock of a company at say ₹ 1000 while in the futures market it trades at a discount to the spot price say at ₹ 980 then the fund may sell the stock and buy the futures. On the date of expiry of the stock future, the fund may reverse the transactions (i.e. Buying at Spot & Selling futures) and earn a risk-free ₹ 20/- (2% absolute) on its holdings. As this can be without any dilution of the view of the fund on the underlying stock the fund can still benefit from any movement of the price in the northward direction, i.e. if on the date of expiry of the futures, if the stock trades at 1100 which would be the price of the futures too, the fund will have a benefit of ₹ 100/- whereby the fund gets the 10% upside movement together with the 2% benefit on the arbitrage, and thus getting a total return of 12%.

Risk associated with this strategy:

- Lack of opportunities available in the market
- Risk of mispricing or improper valuation
- Inability of the derivatives to correlate perfectly with underlying security
- Execution risk, whereby the rates seen on the screen may not be the rates at which the ultimate execution takes place.
- (b) **Buying spot and selling future:** Where the stock of a company is trading in the spot market at ₹ 1000 while the futures trades at ₹ 1020/- in the futures market then fund may buy the stock at spot and sell in the futures market thereby earning ₹ 20. In case of adequacy of cash with the fund, this strategy may be used to enhance returns of the Scheme which was otherwise sitting on cash.

Risk associated with this strategy:

- Lack of opportunities available in the market
- Risk of mispricing or improper valuation
- Inability of the derivatives to correlate perfectly with underlying security
- Execution risk, whereby the rates seen on the screen may not be the rates at which the ultimate execution takes place.
- (c) **Buying stock future:** Where the scheme wants to initiate a long position in a stock whose spot price is at say, ₹1000 and futures is at ₹ 980, then the fund may just buy the futures contract instead of the spot thereby benefiting from a lower cost.

Risk associated with this strategy:

- Lack of opportunities available in the market
- Risk of mispricing or improper valuation
- Inability of the derivatives to correlate perfectly with underlying security
- Execution risk, whereby the rates seen on the screen may not be the rates at which the ultimate execution takes place.

The AMC retains the right to enter into such derivative transactions as may be permitted by the applicable regulations from time to time.

RISK CONTROL:

The asset allocation of the Scheme will be steadily monitored and it shall be ensured that investments are made in accordance with the scheme objective and within the regulatory and internal investment restrictions prescribed from time to time.

A detailed process has been designed to identify, measure, monitor and manage portfolio risk.

Some of the risks and the corresponding risk mitigating strategies are listed below:

For debt portion (debt and money market instruments):

PORTFOLIO TURNOVER:

The Scheme portfolio will be managed keeping in mind the Scheme objective. The portfolio turnover will mainly depend upon the circumstances prevalent during the tenure of the portfolio. However, it is anticipated that the overall portfolio turnover would be comparatively lower than an open ended scheme and does not have a target for portfolio turnover. The Fund Manager will endeavour to optimize portfolio turnover to maximize gains and minimize risks keeping in mind the cost associated with it. However, it is difficult to estimate with reasonable measure and accuracy, the likely turnover in the portfolio of the Scheme.

F. FUNDAMENTAL ATTRIBUTES

Following are the Fundamental Attributes of the Scheme, in terms of Regulation 18 (15A) of the SEBI (MF) Regulations:

(i) Type of a Scheme

A Close-ended Capital Protection Oriented Scheme.

(ii) Investment Objective

Main Objective:

The investment objective of the Scheme is to seek capital protection on maturity by investing in fixed income securities maturing on or before the tenure of the scheme and seeking capital appreciation by investing in equity and equity related instruments.

However, there is no assurance that the investment objective of the Scheme will be realized and the Scheme does not assure or guarantee any returns. The Scheme is "oriented towards protection of capital" and not "with guaranteed returns". Further, the orientation towards protection of the capital originates from the portfolio structure of the scheme and not from any bank guarantee, insurance cover etc.

Investment Pattern:

The indicative portfolio break-up with minimum and maximum asset allocation is detailed in the section 'How will the Scheme Allocate its Assets?' in this document. The fund manager reserves the right to alter the asset allocation for a short term period on defensive considerations.

(iii) Terms of Issue

• Liquidity provisions such as Listing, Repurchase, Redemption:

Listing - The Units of the Scheme are proposed to be listed on a recognized Stock Exchange(s) in India, as may be approved by the Trustee. For details, please refer to provision on 'Listing' in this document.

Units of the scheme will be redeemed only on the maturity date (or immediately succeeding Business Day if the maturity date falls on a non-business day). For details, please refer provision on 'Redemption' in this document.

Aggregate fees and expenses charged to the Scheme:

The aggregate fees and expenses charged to the Scheme will be in line with the limits defined in the SEBI (MF) Regulations as amended from time to time. The aggregate fees and expenses to be charged to the Scheme is detailed in Section IV of this document.

Any safety net or guarantee provided:

The Scheme does not provide any safety net or guarantee nor does it provide any assurance regarding the realization of the investment objective of the scheme or in respect of declaration of dividend. Further, the Scheme is "oriented towards protection of capital" and not "with guaranteed returns". Further, the orientation towards protection of the capital originates from the portfolio structure of the scheme and not from any bank guarantee, insurance cover etc.

In accordance with Regulation 18(15A) of the SEBI (MF) Regulations, the Trustee shall ensure that no change in the fundamental attributes of the Scheme or the trust or fee and expenses payable or any other change which would modify the Scheme and affect the interests of Unit Holders is carried out unless:

- A written communication about the proposed change is sent to each Unit Holder and an
 advertisement is given in one English daily newspaper having nationwide circulation as well
 as in a newspaper published in the language of the region where the Head Office of the
 Mutual Fund is situated; and
- The Unit Holders are given an option for a period of 30 days to exit at the prevailing Net Asset Value without any exit load.

However, changes / modifications to the Scheme made in order to comply with any subsequent change in Regulations or circulars issued by SEBI will not constitute change in fundamental attributes.

G. HOW WILL THE SCHEME BENCHMARK ITS PERFORMANCE?

The performance of the Scheme will be benchmarked against a customised Benchmark Index as mentioned below:

• 85% CRISIL Short Term Bond Fund Index (+) 15% Nifty 50 Index

The daily values of the customised Benchmark Index will be internally computed by the AMC with proper checks and balances in place. These daily values will be computed on the basis of the daily values of the underlying Indices.

Justification for use of benchmark

The Scheme intends to invest in a portfolio of instruments, the risk-return profile of which is best captured by the customised Benchmark Index. This customised benchmark shall provide the investor with an independent and representative comparison with fund portfolio.

Performance of the Scheme vis-à-vis the Benchmark and peers will be periodically discussed and reviewed by the Investment Committee of the AMC and Board of Directors of the AMC and Trustee Company in their respective meetings.

The Trustee reserves the right to change the benchmark for the evaluation of the performance of the Scheme from time to time, keeping in mind the investment objective of the Scheme and the appropriateness of the benchmark, subject to the Regulations and other prevalent guidelines.

I. WHAT ARE THE INVESTMENT RESTRICTIONS?

Investment restrictions as contained in the SEBI (MF) Regulations specifically in the Seventh Schedule of the Regulations including any amendments thereto and SEBI circulars issued from time to time and as applicable to the Scheme are provided below:

1) The Scheme shall not invest more than 10% of its NAV in debt instruments comprising money market instruments and non-money market instruments issued by a single issuer which are rated not below investment grade by a credit rating agency authorised to carry out such activity under the SEBI Act, 1992. Such investment limit may be extended to 12% of the NAV of the Scheme with the prior approval of the Board of Trustee and the Board of directors of the AMC.

Provided that such limit shall not be applicable for investments in Government Securities, treasury bills and CBLOs.

Provided further that investment within such limit can be made in mortgaged backed securitised debt which are rated not below investment grade by a credit rating agency registered with SEBI."

- 2) The scheme shall not invest in unrated debt instruments. For this purpose, unrated securities shall exclude instruments such as CBLO, Reverse Repo, short term deposits and mutual fund units to which rating is not applicable.
- 3) Transfers of investments from one scheme to another scheme in the same mutual fund shall be allowed only if,—
 - (a) such transfers are done at the prevailing market price for quoted instruments on spot basis.

[Explanation.—"Spot basis" shall have same meaning as specified by stock exchange for spot transactions;]

- (b) the securities so transferred shall be in conformity with the investment objective of the scheme to which such transfer has been made.
- 4) The Scheme may invest in other schemes of the Mutual Fund or any other mutual fund (restricted to only debt and Liquid funds) without charging any fees, provided the aggregate inter-scheme

investment made by all the schemes under the same management or in schemes under the management of any other asset management company shall not exceed 5% of the Net Asset Value of the Mutual Fund.

- 5) The Scheme shall buy and sell securities on the basis of deliveries and shall in all cases of purchases, take delivery of relevant securities and in all cases of sale, deliver the securities.
 - Provided further that the Mutual Fund may enter into Derivatives transactions in a recognized stock exchange, subject to the framework specified by SEBI.
 - Provided further that the sale of government security already contracted for purchase shall be permitted in accordance with the guidelines issued by the RBI in this regard.
- 6) The Mutual Fund shall get the securities purchased/transferred in the name of the Fund on account of the concerned Scheme, wherever investments are intended to be of a long-term nature.
- 7) Pending deployment of the funds of the Scheme in securities in terms of the investment objective of the Scheme, the Mutual Fund may park the funds of the Scheme in short term deposits of scheduled commercial banks, subject to the following guidelines issued by SEBI vide its circular dated April 16, 2007 as may be amended from time to time:
 - i. "Short Term" for such parking of funds by the Scheme shall be treated as a period not exceeding 91 days. Such short-term deposits shall be held in the name of the Scheme.
 - ii. The Scheme shall not park more than 15% of the net assets in short term deposit(s) of all the scheduled commercial banks put together. However, such limit may be raised to 20% with prior approval of the Trustee.
 - iii. Parking of funds in short term deposits of associate and sponsor scheduled commercial banks together shall not exceed 20% of total deployment by the Mutual Fund in short term deposits.
 - iv. The Scheme shall not park more than 10% of the net assets in short term deposit(s), with any one scheduled commercial bank including its subsidiaries.
 - v. The Scheme shall not park funds in short term deposit of a bank which has invested in that Scheme.
 - vi. The AMC will not charge any investment management and advisory fees for parking of funds in short term deposits of scheduled commercial banks in case of liquid and debt oriented schemes.
 - vii. The above norms do not apply to term deposits placed as margins for trading in cash and derivatives market, as applicable.
- 8) The scheme shall not make any investment in:
 - i) Any unlisted security of an associate or group company of the sponsor; or
 - ii) Any security issued by way of private placement by an associate or group company of the sponsor; or
 - iii) The listed securities of group companies of the sponsor which is in excess of 25% of the net assets of the Scheme.
- 9) The Scheme shall not make any investment in any fund of funds scheme.
- 10) The scheme shall not advance any loans for any purpose.

- 11) The Fund shall not borrow except to meet temporary liquidity needs of the Fund for the purpose of repurchase/redemption of Units or payment of interest and/or Dividend to the Unit holder.
 - The Fund shall not borrow more than 20% of the net assets of the Scheme and the duration of the borrowing shall not exceed a period of 6 months.
- 12) The Mutual Fund under all its Scheme(s) shall not own more than 10% of any company's paid up capital carrying voting rights.
- 13) The Scheme shall not invest more than 10% of its net assets in equity shares or equity related instruments of any company.
- 14) The Scheme shall not invest more than 10% of its net assets in unlisted equity shares or equity related instruments.
- 15) The Scheme shall invest only in such securities which mature on or before the date of the maturity of the scheme.
- 16) In accordance with SEBI (MF) Regulations and circulars thereto, the debt component of the portfolio will have highest investment grade rating.
- 17) The total exposure of the Scheme in a particular sector (excluding investments in Bank CDs, CBLO, G-Secs, T-Bills, short term deposits of scheduled commercial banks and AAA rated securities issued by Public Financial Institutions and Public Sector Banks) shall not exceed 25% of the net assets of the Scheme. For the purposes of the sector exposure limit, AMFI sector classification of issuers would be considered.

Provided that the Scheme may have an additional exposure to financial services sector (over and above the limit of 25%) not exceeding 10% of the net assets of the Scheme by way of increase in exposure to Housing Finance Companies (HFCs). Provided further that the additional exposure to such securities issued by HFCs are rated AA and above and these HFCs are registered with National Housing Bank (NHB) and the total investment/ exposure in HFCs shall not exceed 25% of the net assets of the Scheme.

18) The total exposure of the Scheme in a group (excluding investments in securities issued by Public Sector Units, Public Financial Institutions and Public Sector Banks) shall not exceed 20% of the net assets of the Scheme. Such investment limit may be extended to 25% of the net assets of the Scheme with the prior approval of the Board of Trustees. For this purpose, a group means a group as defined under regulation 2 (mm) of SEBI (Mutual Funds) Regulations, 1996 and shall include an entity, its subsidiaries, fellow subsidiaries, its holding company and its associates.

19) Limitations and restrictions for investments in derivatives

SEBI has vide its circular DNPD/Cir-29/2005 dated September 14, 2005 interalia specified the guidelines pertaining to trading by Mutual Funds in Exchange Traded derivatives. The position limits have subsequently been modified vide circulars interalia including circular no. DNPD/Cir-30/2006 dated January 20, 2006, circular no. SEBI/DNPD/Cir-31/2006 dated September 22, 2006 and circular no. SEBI/HO/MRD/DP/CIR/P/2016/143 dated December 27, 2016.

All derivative position taken in the portfolio would be guided by the following principles.

i. Position limit for the Mutual Fund in index options contracts

- a. The Mutual Fund position limit in all index options contracts on a particular underlying index shall be ₹ 500 crore or 15% of the total open interest of the market in equity index options, whichever is higher, per Stock Exchange.
- b. This limit would be applicable on open positions in all options contracts on a particular underlying index.

ii. Position limit for the Mutual Fund in index futures contracts:

- a. The Mutual Fund position limit in all index futures contracts on a particular underlying index shall be ₹ 500 crore or 15% of the total open interest of the market in equity index futures, whichever is higher, per Stock Exchange.
- b. This limit would be applicable on open positions in all futures contracts on a particular underlying index.

iii. Additional position limit for hedging:

In addition to the position limits at point (i) and (ii) above, the Mutual Fund may take exposure in equity index derivatives subject to the following limits:

- 1. Short positions in index derivatives (short futures, short calls and long puts) shall not exceed (in notional value) the Mutual Fund's holding of stocks.
- 2. Long positions in index derivatives (long futures, long calls and short puts) shall not exceed (in notional value) the Mutual Fund's holding of cash, government securities, T-Bills and similar instruments.

iv. Position limit for Mutual Fund for stock based derivative contracts:

The Mutual Fund position limit in a derivative contract on a particular underlying stock, i.e. stock option contracts and stock futures contracts, is defined in the following manner:-

- 1. The combined futures and options position limit shall be 20% of the applicable Market Wide Position Limit (MWPL).
- 2. The MWPL and client level position limits however would remain the same as prescribed earlier.

v. Position limit for each scheme of a Mutual Fund for stock based derivatives contracts:

The scheme-wise position limit / disclosure requirements shall be -

- 1. For stock option and stock futures contracts, the gross open position across all derivative contracts on a particular underlying stock of a scheme of a mutual fund shall not exceed the higher of:
- 1% of the free float market capitalisation (in terms of number of shares) or 5% of the open interest in the derivative contract on a particular underlying stock (in terms of number of contracts).
- 2. This position limits shall be applicable on the combined position in all derivative contracts on an underlying stock at a Stock Exchange.
- 3. For index based contracts, Mutual Funds shall disclose the total open interest held by its scheme or all schemes put together in a particular underlying index, if such open interest equals to or exceeds 15% of the open interest of all derivative contracts on that underlying index.

Exposure limits for the Scheme: The scheme shall comply with SEBI Circular No. Cir / IMD/ DF/ 11/ 2010 dated August 18, 2010. In accordance with SEBI Circular No. Cir/ IMD/ DF/ 11/ 2010 dated August 18, 2010; the following exposure limits for investment in derivatives will be applicable to the Scheme:

- 1. The cumulative gross exposure through equity, debt and derivative positions shall not exceed 100% of the net assets of the Scheme. However, cash or cash equivalents with residual maturity of less than 91 days shall be treated as not creating any exposure.
- 2. The Scheme shall not write options or purchase instruments with embedded written options.
- 3. The total exposure related to option premium paid shall not exceed 20% of the net assets of the Scheme.

- 4. Exposure due to hedging positions shall not be included in the above mentioned limits subject to the following:
 - a. Hedging positions are the derivative positions that reduce possible losses on an existing position in securities and till the existing position remains.
 - b. Hedging positions cannot be taken for existing derivative positions. Exposure due to such positions shall be added and treated under limits mentioned in point 1 above.
 - c. Any derivative instrument used to hedge shall have the same underlying security as the existing position being hedged.
 - d. The quantity of underlying associated with the derivative position taken for hedging purposes shall not exceed the quantity of the existing position against which hedge has been taken.
- 5. Exposure due to derivative positions taken for hedging purposes in excess of the underlying position against which the hedging position has been taken, shall be treated as exposure for the limit mentioned in point 1 above.
- 6. **Definition of Exposure in case of Derivative Positions**: Each position taken in derivatives shall have an associated exposure as defined under. Exposure is the maximum possible loss that may occur on a position. However, certain derivative positions may theoretically have unlimited possible loss.

Exposure in derivative positions shall be computed as follows:

The Trustee may alter the above restrictions from time to time to the extent that changes in the Regulations may allow and as deemed fit in the general interest of the Unit Holders.

The Scheme will comply with the other Regulations applicable to the investments of Mutual Funds from time to time.

As the Scheme, does not intend to engage in short selling/securities lending or invest in securitised debt or debt derivatives or participate in Repo/Reverse Repo transactions in corporate debt securities or participate in credit default swap transactions or invest in overseas/foreign securities, the investment restrictions relating to short selling/securities lending or securitised debt or debt derivatives or Repo/Reverse repo transactions in corporate debt securities or credit default swap transactions or overseas/foreign securities, if any, have not been included in this document.

Apart from the Investment Restrictions prescribed under the Regulations, internal risk parameters for limiting exposure to a particular scrip or sector may be prescribed from time to time to respond to the dynamic market conditions and market opportunities.

The AMC/Trustee may alter these above stated restrictions from time to time to the extent the Regulations change, so as to permit the Scheme to make its investments in the full spectrum of permitted investments for mutual funds to achieve its respective investment objective.

All the investment restrictions will be applicable at the time of making investments. Changes do not have to be effected merely because of appreciations or depreciations in value of the investments, or by reason of receipt of any rights, bonuses or benefits in the nature of capital or of any schemes of arrangement or of amalgamation, reconstruction or exchange, or at any repayment or redemption or

other reason outside the control of the Fund resulting in any of the above limits getting breached. However, the AMC shall take appropriate corrective action as soon as possible, taking into account the interests of the Unit holders.

J. HOW HAS THE SCHEME PERFORMED?

This Scheme is a new scheme and does not have any performance track record.

K. DEBT AND MONEY MARKETS IN INDIA

The Indian debt market is today one of the largest in Asia and includes securities issued by the Government (Central & State Governments), public sector undertakings, other government bodies, financial institutions, banks and corporates. Government and public sector enterprises are the predominant borrowers in the markets. Securities in the debt market typically vary based on their tenure and rating. The major players in the Indian debt markets today are banks, financial institutions, mutual funds, insurance companies, primary dealers, trusts, pension funds and corporates. The Indian debt market is the largest segment of the Indian financial markets. The debt market comprises broadly of two segments, viz. Government Securities market or G-Sec market and corporate debt market. The latter is further classified as market for PSU bonds and private sector bonds. The Government Securities market is the oldest and the largest component of the Indian debt market in terms of market capitalization, outstanding securities and trading volumes. The G-Sec market plays a vital role in the Indian economy as it provides the benchmark for determining the level of interest rates in the country through the yields on the Government Securities which are referred to as the risk-free rate of return in any economy. Over the years, there have been new products introduced by the RBI like zero coupon bonds, floating rate bonds, inflation indexed bonds, etc.

The corporate bond market, in the sense of private corporate sector raising debt through public issuance in capital market, is only an insignificant part of the Indian Debt Market. A large part of the issuance in the non-Government debt market is currently on private placement basis.

The money markets in India essentially consist of the call money market (i.e. market for overnight and term money between banks and institutions), reverse repo transactions (temporary buy with an agreement to sell the securities at a future date at a specified price), commercial papers (CPs, short term unsecured promissory notes, generally issued by corporates), certificate of deposits (CDs, issued by banks) and Treasury Bills (issued by RBI) and similar securities. In a predominantly institutional market, the key money market players are banks, financial institutions, insurance companies, mutual funds, primary dealers and corporates. In money market, activity levels of the Government and non-government debt vary from time to time.

Apart from these, there are some other options available for short tenure investments that include MIBOR linked debentures with periodic exit options and other such instruments. PSU / DFI / Corporate paper with a residual maturity of less than 1 year are actively traded and offer a viable investment option.

These yields are indicative and do not indicate yields that may be obtained in future as interest rates keep changing consequent to changes in macro-economic conditions and RBI policy. The price and yield on various debt instruments fluctuate from time to time depending upon the macro economic situation, inflation rate, overall liquidity position, foreign exchange scenario etc. Also, the price and yield vary according to maturity profile, credit risk etc.

L. RATING DETAILS:

CARE vide its letter dated **July 17, 2015 and December 15, 2016**, has rated this Scheme as '**CARE AAAmfs (SO)**' [pronounced as CARE Triple A mfs (Structured Obligation)]. The rating indicates highest degree of safety regarding timely receipt of payments from the investments that the Scheme has made. The rating is subject to the Scheme receiving the regulatory approvals and fulfilment of all conditions specified in the structural provisions by CARE.

The income earned under this option will get accumulated as capital accretion and will continue to remain invested in the Scheme and will be reflected in the NAV of the Units held under this option. Dividend option

This Option is suited for investors seeking income through dividend declared. The dividend will be declared at the time of maturity [subject to availability of distributable surplus calculated in accordance with SEBI (MF) Regulations], and at the discretion of the Trustees.

Dividend declared will be paid out (subject to deduction of dividend distribution tax and statutory levy, if any) to those Unit holders, whose names appear in the Register of Unit holders on the notified Record Date.

Facilities under the Dividend Option:

Dividend Policy

The Trustee will declare dividend under the Dividend Option at the time of maturity, subject to availability of distributable surplus calculated in accordance with the Regulations.

Dividend Declaration Procedure:-

Pursuant to SEBI Circular no SEBI/IMD/CIR No.1/64057/06 dated April 4, 2006, the procedure for dividend distribution would be as under:

- The AMC shall issue a notice to the public communicating the decision of dividend declaration including the record date, within one calendar day of the decision of the Trustee, in one English daily newspaper having nationwide circulation as well as in a newspaper published in the language of the region where the head office of the Mutual Fund is situated.
- However, such a notice shall not be given for Dividend Options having dividend distribution frequency ranging from daily up to monthly distribution, if any.
- Pursuant to payment of dividend, the NAV of the Dividend Option will fall to the extent of the dividend payout and applicable statutory levies, if any.

Effect of Dividends:

The investors should note that the Fund does not assure or guarantee declaration of dividends under the Dividend Option. The actual declaration of dividend, frequency and the rate of dividend will interalia, depend on availability of distributable surplus calculated in accordance with SEBI (MF)

Regulations and the decisions of the Trustee shall be final in this regard. There is no assurance or guarantee to the unit holders as to the rate of Dividend nor that the dividend will be paid at the time of maturity.

Post declaration of dividend, the NAV of the Units under the Dividend Option will stand reduced by the amount of dividend declared and applicable dividend distribution tax/ surcharge/cess/any other statutory levy.

Option to hold Units in dematerialised form.

The Unit holders are given an option to hold the Units in physical form (by way of an account statement) or in dematerialized form (Demat).

Each Option under each Plan held in the dematerialised form shall be identified on the basis of an International Securities Identification Number (ISIN) allotted by National Securities Depositories Limited (NSDL) and Central Depository Services Limited (CDSL). The ISIN No. details of the respective option under the respective Plan can be obtained from your Depository Participant (DP) or you can access the website link www.nsdl.co.in or www.cdslindia.com. The holding of units in the dematerialised mode would be subject to the guidelines/ procedural requirements as laid by the Depositories viz. NSDL/CDSL from time to time.

<u>Subscription of units under Dematerialised Mode & allotment thereof:</u>

The Applicants intending to hold the Units in dematerialised mode will be required to have a beneficiary account with a DP of the NSDL/CDSL and will be required to mention the DP's Name, DP ID No. and Beneficiary Account No. with the DP in the application form at the time of subscription/additional purchase of the Units of the Scheme/Plan/Option.

The applicant shall mandatorily attach a self-attested copy of the latest demat account statement/client master statement along with the application forms at the time of initial subscription. The application for subscription would be liable to be rejected by the AMC/ Registrar under the following conditions:

- a. In case the applicants do not provide their Demat Account details in the application form; or
- The demat details provided in the application form are incomplete / incorrect or do not exactly match with the details in the Depository records; and/or

Account Statement (for non-demat account holders): An account statement stating the number of units purchased and allotted will be sent through ordinary post or courier and/or electronic mail to each unitholder who has not provided his demat account details in the application form for subscription during the NFO, within 5 business days from the closure of NFO period. - NRIs residing in Non-Compliant Countries and Territories (NCCTs) as determined by the Financial Action Task Force (FATF), from time to time.
- NRIs and PIOs who are residents of the United States of America/defined as United States Persons under applicable laws/ statutes and the residents of Canada.

- Qualified Foreign Investor/ QFI as defined in this document.
- Such other persons as may be specified by AMC / Regulatory Authorities from time to time.

Where can you submit the filled up applications.

Duly completed application forms for purchase of units under the Scheme during the NFO period along with the instrument for payment may be submitted to any of the Official Points of Acceptance for the NFO or as notified by the AMC.

Please refer the back cover page of this document for address, contact details and website address of the Registrar and Transfer Agent, Official Points of Acceptance, collecting banker details etc.

During the NFO period, apart from the current process of payment wherein cheques/demand drafts (if permitted) etc. are used as a mode of payment, an investor also has the option to subscribe to the units of this Scheme using the Application Supported by Blocked Amount (ASBA) facility. This facility is available to all categories of investors mentioned under the heading 'Who can invest?'.

Investors using the ASBA facility are requested to carefully read the detailed provisions related to ASBA given in the SAI, as application procedures under this facility are different from the application procedures otherwise followed.

As per SEBI Circular No. CIR/IMD/DF/21/2012 dated September 13, 2012 and SEBI Circular No. CIR/IMD/DF/10/2014 dated May 22, 2014, cash transactions in mutual funds have been permitted to the extent of ₹ 50,000/per investor, per mutual fund, per financial year subject to compliance with prescribed norms. However, currently the AMC/Mutual Fund does not accept cash transactions in the Schemes of Union Mutual Fund.

Applicants using the ASBA facility may submit the ASBA application form to the Self Certified Syndicate Banks (SCSBs) directly or through the syndicate/sub syndicate members, authorising the SCSB to block funds available in the investor's bank account specified in the ASBA application form and maintained with the SCSB. The SCSB shall then block an amount equal to the application amount in the specified bank account until scrutiny of the documents by the Registrar and consequent transfer of the application amount to the account of the Scheme for full and firm allotment of units or until rejection of the application on failure to raise minimum target amount or due to any other reason, as the case may be. For detailed provisions relating to ASBA facility the investors are requested to refer to the SAI.

An application Form accompanied by a payment instrument issued from a bank account other than that of the Applicant / Investor will not be accepted except in certain circumstances. Listing

The Units of the Scheme are proposed to be listed on NSE within 5 Business Days from the date of allotment or within such time as the Regulations permit. NSE has vide its letter No. NSE/LIST/98220 dated December 23, 2016, provided an in-principle approval to the Mutual Fund for listing of the Units of the Scheme on NSE.

The Mutual Fund may at its sole discretion list the Units on any other recognized Stock Exchange(s) at a later date. The AMC/Trustee shall issue an addendum for listing of Units on any other recognised Stock Exchange in India, and a public notice to this effect will be given in two daily newspapers and also displayed at the Customer Service Centres. All regulatory procedures will be followed in this regard.

An investor can buy/sell Units on a continuous basis on NSE and/or any other Stock Exchange(s) on which the Units are listed during the trading hours like any other publicly traded stock, until the date of suspension of trading as mentioned in the notice issued by the AMC in this regard and for fixing the Record Date for determining the Unit holders whose name(s) appear on the list of beneficial owners as per the Depository's (NSDL/CDSL) records for the purpose of redemption of Units on maturity. The trading of Units on NSE and/or any other Stock Exchange(s) on which the Units are listed will automatically get suspended from the date as may be specified in such notice and also no off-market trades shall be permitted by the Depositories.

The price of the Units in the market will depend on demand and supply and market factors and forces at that point of time. There is no minimum investment, although Units are purchased in round lots of 1.

As the Stock Exchange(s) do not allow trading of fractional units, Units may be allotted only in integers by rounding off the Units allotted to the lower integer and the balance amount may be refunded to the investor.

<u>Transaction Cost</u>: Though there will be no entry/exit load for buying/selling the Units from/to the secondary market, the investors will have to bear the other costs related to transacting in the secondary market, e.g. brokerage, service tax, etc.

Unitholders who wish to trade in units through the Stock Exchanges would be required to have a demat account.

The Scheme will be de-listed after the completion of its tenure. The AMC/Trustee will initiate the delisting procedure prior to the date of maturity. The Unit holders will not be able to trade on the NSE once the Scheme is delisted.

Special Products / facilities available during the NFO

Switching:

During the NFO period (switch request will be accepted upto 3.00 p.m. on the last day of the NFO), the Unit holders will be able to invest into the NFO of the Scheme by switching part or all of their Unit holdings held in an existing scheme(s) of the Mutual Fund.

The switch will be effected by way of a redemption of units from such other scheme and a reinvestment of the redemption proceeds in the Scheme and accordingly, to be effective, the switch must comply with the redemption rules of such other scheme and the issue rules of the Scheme (e.g. as to the minimum number of units that may be redeemed or issued, exit load

etc). The price at which the units will be switched-out of the other scheme will be based on the redemption price and the proceeds will be invested in this Scheme at ₹10/- per unit (NFO price). Residual value, if any (less than ₹10/-) will be refunded to the respective investors.

<u>Auto Switch of Redemption Proceeds of Union Capital Protection</u> Oriented Fund - Series 7 on Maturity:

The investors have an option of switching their redemption proceeds receivable on maturity of the Scheme to 'Union Liquid Fund'. Investors can avail of this facility by indicating their intention in the application form at the time of subscribing the units of the Scheme during the NFO period. However, to make the switch effective, investor needs to hold all the units till maturity of the scheme. The switch out transaction will be processed based on the applicable Net Asset Value (NAV) on the date of maturity. Further, for the switch to be effective, the switch must comply with the redemption rules of this Scheme and the issue rules of the Scheme into which units are being switched (e.g. Applicable NAV, minimum number of units that may be redeemed or issued, exit load etc.).

However, investors shall have an option to alter preference from auto switch on maturity to Payout Option by submitting a written request at any of the CSCs / Official Points of Acceptance, at any time during the tenure of the scheme, but, not later than 7 working days before the date of maturity of the scheme.

The facility of transacting in Union Mutual Fund schemes through NMF-II is available subject to operating guidelines, terms and conditions as may be prescribed by the NSE/Clearing Corporation/Depositories from time to time. The AMC reserves the right to call for incremental documents from its investors. For further details on this facility, please refer the section on "Facility to purchase/ redeem units of the Scheme through Stock Exchange Mechanism" in the SAI. The policy regarding Units once redeemed will be extinguished and will not be reissued. reissue Repurchased Units, including maximum extent, the manner of reissue, the entity (the Scheme or the AMC) involved in the same.

The Units of the Scheme are not transferable except for Units held in

For normal transactions during ongoing sales and repurchase:

- The Account Statement reflecting Redemption / Switch out of Units shall be dispatched to the Unit Holder within 10 Business Days from the Maturity Date of the Scheme.

- In case of investors in whose folios no transaction has taken place during any half yearly period ended September/ March, a CAS for such a half yearly period shall be sent by AMC/ RTA, on or before tenth day of succeeding month, detailing the holding at the end of the respective six month period across all Schemes of all mutual funds.
- A CAS for the half-year (ended September / March) containing additional disclosures such as the amount of actual commission paid by the AMC/Mutual Fund to distributors (in absolute terms) during the halfyear period and the scheme's average Total Expense Ratio (in percentage terms) for the half-year period for each scheme's applicable plan where

the concerned investor has actually invested in shall be issued to investors. This CAS shall be issued to investors, excluding investors who do not have any holdings in the schemes and where commission against their investment has been paid to distributors, during the concerned half-year period.

ii) Investors who hold Demat Account:

- A CAS for each calendar month shall be sent by Depositories to investors holding a demat account, on or before tenth day of the succeeding month, detailing all the transactions and holding at the end of the month, across all Schemes of all Mutual Funds and across demat accounts to all the investors in whose folios / demat accounts transaction has taken place during that month.
- In case of investors in whose folios and demat accounts no transaction has taken place during any half yearly period ended September/ March, a CAS for such a half yearly period shall be sent by Depositories, on or before tenth day of succeeding month, detailing the holding at the end of the respective six month period across all Schemes of all mutual funds and across demat accounts of such investors.
- A CAS for the half-year (ended September / March) containing additional disclosures such as the amount of actual commission paid by the AMC/Mutual Fund to distributors (in absolute terms) during the halfyear period and the scheme's average Total Expense Ratio (in percentage terms) for the half-year period for each scheme's applicable plan where the concerned investor has actually invested in shall be issued to investors. This CAS shall be issued to all investors, excluding those investors who do not have any holdings in the schemes and where commission against their investment has been paid to distributors, during the concerned

half-year period.

- The dispatch of CAS by the Depositories would constitute compliance by the AMC/ the Mutual Fund with the requirement under Regulation 36(4) of SEBI (Mutual Funds) Regulations, 1996.
- In case an investor has demat accounts with multiple Depositories, the Depository with whom the account has been opened earlier will be the default Depository. However, the investor shall be given an option by the default depository to choose the depository through which the investor wishes to receive the CAS.
- Investors who do not wish to receive CAS sent by Depositories have an option to indicate their negative consent. Such investors may contact the Depositories to opt out. - e) In case the PAN / KYC valid status is not updated in any folio, details under such folio would not be consolidated. Investors are therefore requested to ensure that their folios are updated with PAN/ KYC valid status.
- f) The statement sent within the time frame mentioned above is subject to realisation of payment instrument and/ or verification of documents, including the application form, by the RTA/AMC.
- g) In case of any queries, investors may contact the Depositories or any of the Customer Service Centres of Union Mutual Fund.
- h) Investors may note that dispatch of CAS across all mutual funds and Depositories requires consolidation of transactions and holdings across all Fund Houses and Depositories, and the AMC shall not be responsible for any errors/ omissions except any error/omission pertaining to transactions and holdings relating to any Schemes of Union Mutual Fund.
- Each CAS issued to the investors shall also provide the total purchase value / cost of investment in each scheme.
- j) For the purpose of CAS containing additional disclosures such as the amount of actual commission paid by the AMC/Mutual Fund to distributors, the term 'commission' refers to all direct monetary payments and other payments made in the form of gifts / rewards, trips,

	event sponsorships etc. by the AMC/Mutual Fund to distributors. Further, the commission disclosed in the CAS is gross commission and does not exclude costs incurred by distributors such as service tax (wherever applicable, as per existing rates), operating expenses, etc.
Dividend	The dividend warrants shall be dispatched to the unitholders within 30 days of the date of declaration of the dividend.
	In case of Unit holders having a bank account with certain banks with which the Mutual Fund would have an arrangement from time to time, the dividend proceeds shall be electronically credited to their account.

Investors also have an option of 'Auto Switch of Redemption Proceeds of Union Capital Protection Oriented Fund -Series 7 on Maturity' the details of which are provided under point viz. 'Special Products / facilities available during the NFO' under Sub-Section A viz. 'New Fund Offer' under Section III viz. 'Units and Offer' and 'Advance Switch of Redemption Proceeds of Union Capital Protection Oriented Fund - Series 7 on Maturity', the details of which are provided under point viz. 'Special Products/Facilities available' under Sub- Section B viz. 'Ongoing Offer Details' under Section III viz. 'Units and Offer'.

If the maturity date falls on a non-business day, the immediate following business day would be considered as the maturity date. Decision of the AMC in this regard shall be final and binding.

The AMC shall dispatch the Redemption proceeds within 10 working days from the Maturity Date.

Whenever a demat account has been freezed by NSDL/CDSL/SEBI or due to any regulatory authorities, such cases will not be processed for maturity payment, till such time the account freeze is removed and a communication to this effect is received by the AMC or the Registrar.

Please note in order to protect the interest of Unit holders from fraudulent encashment of redemption / dividend cheques, SEBI has made it mandatory for investors to provide their bank details viz. name of bank, branch, address, account type and number, etc. to the Mutual Fund. Applications without complete bank details shall be rejected. The AMC will not be responsible for any loss arising out of fraudulent encashment of cheques / warrants and / or any delay / loss in transit. Also, please refer to point on "Registration of Multiple Bank Accounts in respect of an Investor Folio" and 'Bank Account details mandatory for all investors' given in the SAI.

Bank Mandate under Dematerialised mode:

In case of those unit holders, who hold units in demat form, the bank mandate available with the respective DP will be treated as the valid bank mandate for the purpose of payout at the time of

redemption. In view of the above, Multiple Bank Mandate registration facilities with the AMC will not be applicable to Demat account holders.

Payment of redemption proceeds:

Resident Investors:

In case of Unit holders having a bank account with certain banks with which the Mutual Fund would have an arrangement from time to time, the redemption proceeds shall be electronically credited to their account. In case of specific requests, redemption proceeds will be paid by way of cheques/demand drafts in favour of the unitholder (registered holder of the Unit or, if there are more than one registered holder, only to the first registered holder) with bank account number furnished to the Fund.

Redemption by NRIs:

For NRIs, redemption proceeds will be remitted depending upon the source of investment as follows:

- Where the payment for the purchase of the units redeemed was made out of funds held in NRO account, the redemption proceeds will be credited to the NRI investor's NRO account;
- Where the units were purchased on repatriation basis and the payment for the purchase of the units redeemed was made by inward remittance through normal banking channels or out of funds held in NRE / FCNR account, the redemption proceeds will be credited to his NRE / FCNR / NRO account.

Note:

- i. The Fund will not be liable for any delays or for any loss on account of any exchange fluctuations, while converting the rupee amount in foreign exchange in the case of transactions with NRIs / FIIs.
- ii. Payment to NRI / FII Unit holders will be subject to the relevant laws / guidelines of the RBI as are applicable from time to time (also subject to deduction of tax at source as applicable).
- iii. The Fund may make other arrangements for effecting payment of redemption proceeds in future.

- iv. The cost related to repatriation, if any will be borne by the Investor.
- v In case of investments by NRIs during NFO, at the time of redemption of units, TDS will be deducted at the applicable rate. However, in respect of those Unit Holders who have acquired the Units on the Stock Exchange, the Unit Holders would need to provide a certificate from Chartered а Accountant certifying the details of acquisition of Units to the Fund before the maturity of the Scheme, so as to enable the Fund to deduct TDS at the applicable rates. In the event of such details not being provided, the Fund would deduct TDS on the redemption proceeds assuming face value as the cost of acquisition.

Unclaimed redemptions amounts: Investors may refer to the SAI for details with regard to unclaimed redemption amounts. Investors are also requested to refer to the SAI for details on "Pledge/lien of units."

Delay in payment of redemption /repurchase proceeds/ dividend

The redemption /repurchase proceeds shall be dispatched to the unit holders within 10 Business Days from the date of maturity and the dividend warrants shall be dispatched to the unit holders within 30 days of the date of declaration of the dividend.

In case of delay, the Asset Management Company shall be liable to pay interest to the unit holders at such rate as may be specified by SEBI for the period of such delay (presently @ 15% per annum).

However, the AMC will not be liable to pay any interest or compensation or any amount otherwise, in case the AMC / Trustee is required to obtain from the investor / unit holders, verification of identity or such other details relating to subscription for units under any applicable law or as may be requested by a regulatory body or any government authority, which may result in delay in processing the application.

Non-Financial Transactions

Non-financial transactions will be accepted only for such investors who hold units in physical form (i.e. by way of an Account Statement). For those investors who hold units in Demat mode, all non-financial transaction such as Change in Address, Bank Mandate, Nominee Registration etc. should be routed directly through their DP's as per the

D. COMPUTATION OF NAV

The Net Asset Value (NAV) per unit will be computed by dividing the net assets of the Scheme/Plan/Option by the number of units outstanding under the Scheme/ Plan/ Option on the valuation date.

The Fund will value its investments according to the valuation norms, as per the AMC's valuation policy and as specified in Eighth Schedule of the SEBI (MF) Regulations and amendments thereto, or such norms as may be specified by SEBI from time to time.

The Net Assets Value (NAV) per unit under the Scheme/Plan/Option shall be calculated as follows:

IV. FEES AND EXPENSES

A. NEW FUND OFFER (NFO) EXPENSES

These expenses are incurred for the purpose of various activities related to the NFO like sales and distribution fees paid, marketing and advertising, Registrar & Transfer Agents expenses, printing and stationary, bank charges etc.

In accordance with the provisions of SEBI Circular no. SEBI/ IMD/CIR No. 1/64057/06 dated April 04, 2006 and SEBI/IMD/CIR No. 4/ 168230/09 dated June 30, 2009, the NFO expenses shall be borne by the AMC/Trustee/Sponsor.

B. ANNUAL SCHEME RECURRING EXPENSES

Any payment towards brokerage and transaction cost, over and above the said 12 bps for cash market transactions and 5bps for derivatives transactions may be charged to the scheme within the maximum limit of Total Expense Ratio (TER) as prescribed under regulation 52 of the SEBI (Mutual Funds) Regulations, 1996. Any expenditure in excess of the said prescribed limit (including brokerage and transaction cost, if any) shall be borne by the AMC or by the trustee or sponsor.

The upfront commission on investment made by the investor, if any, shall be paid to the ARN Holder directly by the investor, based on the investor's assessment of various factors including service rendered by the ARN Holder.

E. TRANSACTION CHARGES TO DISTRIBUTORS (Applicable only during the New Fund Offer period)

In accordance with the terms of SEBI Circular No. Cir/ IMD/ DF/13/ 2011 dated August 22, 2011 and SEBI Circular Cir/ IMD/ DF/21/ 2012 dated September 13, 2012 on Transaction Charges, the AMC/Mutual Fund shall deduct the Transaction Charges on purchase / subscription received from first time mutual fund investors and investors other than first time mutual fund investors through the distributor (who have specifically opted-in to receive the transaction charges) as under:

First Time Mutual Fund Investor (across Mutual Funds):

Transaction charge of ₹ 150/- for subscription of ₹ 10,000 and above will be deducted from the subscription amount and paid to the distributor/agent of the first time investor and the balance shall be invested.

Transaction charge of ₹ 100/- per subscription of ₹ 10,000 and above will be deducted from the subscription amount and paid to the distributor/agent of the existing investor and the balance shall be invested.

It may be noted that the transaction charges shall be subject to the following:

- Distributors shall be able to choose to "opt in" OR "opt out" of charging the transaction charge. However, the option exercised by the Distributor is required to be at distributor level and may be based on type of the product but not investor level i.e. a distributor shall not charge one investor and choose not to charge another investor.
- Transaction charges shall not be deducted for (i) purchases/ subscriptions made directly with the Fund (i.e. not through any distributor); (ii) purchase/subscriptions below ₹ 10,000/- and (iii) transactions other than purchases/ subscriptions relating to new inflows.

It may be further noted that the transaction charges are in addition to the existing system of commission permissible to the Distributors. It is further clarified that pursuant to SEBI Circular No. SEBI/IMD/CIR No. 4/ 168230/09, dated June 30, 2009, upfront commission to distributors shall continue to be paid by the investor directly to the distributor by a separate cheque based on his assessment of various factors including the service rendered by the distributor.
